Agenda Item #1 - Submerged pier - Rick D.

Rick D. reported that he had a conversation with the owners of the submerged pier. Owners said that they plan on removing it over the labor day weekend.

Discussion followed about next steps if the pier is not removed, and CLMD jurisdiction. There was a suggestion to hire pier removers and charge the owners the cost of that on their lake district fee, which not everyone agreed with. No action taken.

Agenda Item #2 - Board member term lengths.
