# <u>Water Quality</u> (George Rasmussen)

The Lake District would like to thank George for his 8+ years of performing our water quality sampling. #### **Natural Shores Certification Program**

This awards program honors those landowners that currently meet or exceed the minimum county shoreland zoning ordinance requirements on their waterfront properties. Meeting the minimum shoreland zoning requirements certifies the stewardship as satisfactory. Properties that are being managed in a manner that is significantly higher then the minimum standards required are more beneficial to the health of the water body. These owners are recognized as providing exceptional stewardship of their shorelines. Landowners that have certified shorelines receive a framed certificate from the Land Conservation Dept. (LCD) and the LCD and an embroidered shirt with the program logo.

The shoreline stewardship exhibited by the property owners on Cochran Lake is exceptional when compared to the shorelines of most lakes in Price County. Twelve landowners on Cochran Lake have had the Land Conservation Department inspect their shorelines and certify them under the Natural Shores Program as meeting or exceeding minimum shoreland zoning standards that are currently in place. It would be a note-worthy goal to work toward 100% certification for all shoreland on

Cochran Lake. The excellent condition of the current shoreline on most parcels would see little need for restoration activities and would only involve documenting the shoreline condition that is currently present. Should a parcel be found deficient, the LCD can provide technical and cost-share assistance to easily bring a parcel into compliance. If you would like to have your property certified contact:

When using fertilizers, laundry or dishwasher detergents please choose a phosphorus-free product. Run off from yards and leaching from septic fields increases the amount of phosphorus which in turn promotes undesireable weed growth and algae blooms. If we all use a little caution now it will save us a big problem down the road.



Loons (Pat Schwai)

A pair of loons appeared on Cochran Lake the morning of April 25th! The ice was about 85% out but having waited two extra weeks, the loons weren't about to be fussy.

Will this be the year we have chicks? Last year we found no evidence of a nesting attempt. That wasn't alarming considering that Common Loons may only nest three out of five years. The lake water level may have impacted their decision as well. We remain hopeful that 2008 will be the year our patience is rewarded.

We all need to be mindful of the fact that having resident loons is a privilege. There are many lakes monitored by LoonWatch that are no longer home to loons. Here are a few simple ways YOU can make a difference:

Watch loons from at least 200 feet away.

Be a responsible boater. Boat wakes can wash eggs off a nest.

Avoid exploring or camping on islands before July 15th of each year.

Keep dogs and cats away from loons and nests.

Share these guidelines with your visiting family and friends.

LoonWatch continues their "Get the Lead Out" initiative by urging anglers to use lead-free jigs and sinkers. Ingesting just one lead sinker or jig can kill a loon. We will have an informational display and a list of dealers selling lead-free tackle at the annual meeting. Please take a few minutes to avail yourself of this opportunity.

# What is VHS? (DNR Website)

Viral Hemorrhagic Septicemia (VHS) is a deadly fish virus and an invasive species that is threatening Wisconsin's fish.

How the VHS Rules Affect Anglers?

The new rules state that if you meet one of the conditions below you do not have to dispose of your minnows.

Anglers can take minnows bought from a Wisconsin bait dealer away from a lake or river and use them again on that same waterbody.

Anglers can also take minnows bought from a Wisconsin bait dealer away from a waterbody and use them elsewhere if no lake or river water was added to the bait container.

In both of these instances, you can move the amount of water needed to keep the minnows alive, up to 2 gallons. No other fish may be held in the minnow container.

DNR rules require that you drain all water from your boat, with the exception of the 2 gallons of water allowed for your minnows, including your bilge and livewell if the minnows are not in it. You should always remove all aquatic plants and animals from your boat and trailer before leaving the landing. To keep the access to the lake open, you may pull to a different part of the access, such as the parking lot, to drain your boat and remove any aquatic hitchhikers.

The virus that causes VHS can survive in water for up to 2 weeks. You can sanitize your boat, trailer and equipment by washing it with a mixture of 1/2 cup of household bleach per 5 gallons of water. Allowing your boat and trailer to completely dry out will reduce the risk of infecting other waters.
